NOW THEREFORE THIS DEED OF TRUST declares and WITNESSETH AS FOLLOWS:-

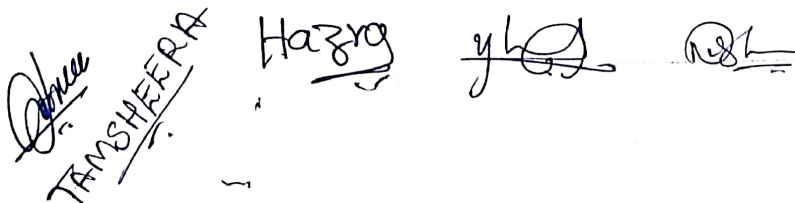

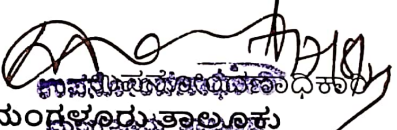

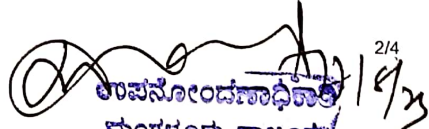

2. To establish and administer Primary School, Pre-University College, Colleges, Medical Colleges, Para-Medical Colleges, Engineering and Technical Colleges, Training Institutions reading room. Symposium and seminars for improving education.
3. To open education centers, libraries, computer centers so as to spread knowledge.
4. To establish and administer Hostels, to provide Residential facilities to the students boys or girls.
5. To start and run Halls, residential institution, hospitals, Medical Centers, Yoga and Dyan Kendra.
6. To establish and administer Ashram to the aged people, children orphans.
7. To give scholar or school fees amount to the poor and needy students
8. To help all the worshipping centers of all community.
9. To conduct, Medical eye camp and Blood donations camp in rural places and educating them about good health and also free distribution of Medicines and specs to the needy persons.

In furtherance of the above mentioned aims and objectives the Trust shall be entitled:

- a) To invest and deal with the funds of the Trust in any manner as the TRUSTEES may decide from time to time to attain the objectives of the Trust.
- b) To sell, improve, manage, develop, exchange, lease out mortgage, dispose off and give on license or otherwise deal with all or any part of the immovable movable properties of the Trust.
- c) To amalgamate, corporate, join or affiliate with any other Trust, Association and organization or Institution or Societies having similar aims and objectives of the Trust either in part or whole as decided by the Board of Trustees.
- d) To obtain and accept subscriptions, donations, grants, gifts, bequests and Trusts from any person or persons, firm or corporation or other body of bodies.
- e) To organize debates, lectures conference, research works, public meetings, classes, exhibition, calculated directly or indirectly to advance the cause of education.
- f) To establish, maintain and run residential institutions, for the students and others and to those connected with Institution of the Trust.

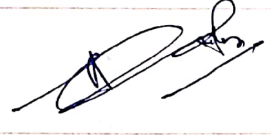

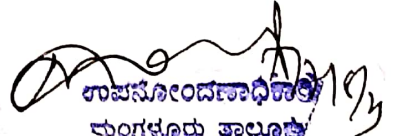

- g) To purchase, acquire, own or obtain on lease or hire or exchange or otherwise any movable or immovable property for the achievement of the objective of the Trust.
- h) To engage teachers, instructors and necessary non-teaching staff, for the maintenance of the Trust or any of the Institution run or maintained by the Trust.
- i) To invest, dispose off, transfer or otherwise deal with the funds of the Trust to achieve the aims and objective of the Trust, in such manner as the Board of Trustees may deem fit.
- j) To take over, or amalgamate or affiliate with any other Trust with similar objectives or work in alliance or in co-operation with such Trusts or institutions upon such Trusts or Institutions upon such terms and conditions as may be decided upon from time to time by the Board of Trustees.
- k) To enter into agreements, contracts or to cancel or vary them.
- l) To open schools, colleges, craft schools, Health centers, technical Institutions by erecting building quarters for the staff members, in pursuance of the objectives of the Trust, and also to maintain develop, or other repair, demolish or reconstruct any of the building under the control of the Trust.
- m) To establish hostels, dispensaries, hospitals or Nursing homes.
- n) To take or receive any gifts, whether in the shape of money properties movables or immovable, donations, deposits, stocks, shares or securities in any company, society, whether incorporated or not.
- o) To receive either by gifts from person living or by legacy bequest, will, or foundation whether subject to any Special trust and not for any one or more of the objectives of the trust, or for the works connected therewith in order to secure such contributions for the funds of the Trust from time to time as deemed fit.
- p) To alienate by way of sale, mortgage, lease, release loan, charge, hypothecation, pledge, exchange, hiring out, gift or otherwise deal with the properties, with or without societies or any portions thereof, to obtain contributions, assistance, pecuniary or other benefits as may be decided by the Board of Trustees.
- q) To invest, lay aside or deposit in Bank or Banks approved by the Board of Trustees or otherwise deal with the moneys or funds of the Trust not immediately required for the achievement of the aims and objectives of the Trust, and subscribe for, purchase, acquire, hold, sell, endorse and negotiate any other

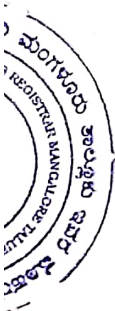

- r) To negotiate with village Panchayath, Taluk Panchayath, Municipalities, City Corporations, Local Authorities, Boards, Universities or other public or private bodies, as may see conducive to the promotion or expanding the aims and objectives of the Trust, and to apply for, obtain, collect, receive or recover from any such Government or authority or body such grants, allowances, rights, concessions, privileges as may see necessary to comply with and to utilize the same.
- s) To use all income derived from the properties movable or immovable of the Trust for the furtherance of the objectives of the Trust.
- t) To make rules and regulations or/and by laws for the conduct of the Trust and its various activities and to vary or alter the same from time to time as decided by the Board of Trustees.
- u) To support and render financial assistance to charitable educational cause Institutions organizations. Trust/Societies in the form of donations loan or otherwise in such terms may be deemed fir or which in the option of the trustees will help the realization of all or any of the object of the Trust.
- v) In general to do all such other things as are incidental, necessary and conducive for the attainment of the above aims and objectives of the Trust.

PART VI **(FUNDS AND PROPERTIES OF THE TRUST)**

The funds properties of the Trust shall comprise of:-

1. Subscription collected from Founder Trustees.
2. Annul contributions received from, affiliated associations and organizations if any,
3. Subscription and donations collected from public.
4. Donations and grants collected from Government and other social organization.
5. Sale proceeds of publications, books, magazines etc.
6. Rent service charges, fees and other moneys collected from hostels, schools, Institutions under the control of the Trust.
7. Movable and immovable properties acquired by the Trust anywhere in India.

8. All funds, properties, rights claims and demands of every description belonging to or pertaining to the Trust now or here afterwards that will be acquired from time to time, shall vest in the trust, and no individual shall have any right over them.
9. The Funds of the Trust shall be invested in the mode specified under the provisions of the Section 13(1) (d) read with Section 11(S) of the Income Tax Act 1961.
10. The funds and Income of the trust shall be solely utilized towards the achievements of the objects no portions of its shall be utilized for payment to trustees/founder by way of profit, interest, dividend etc.
11. At present the coop fund i.e. Rs.5000/- only.

PART VII **BOARD OF TRUSTEES**

1. There shall be Five Trustees.
2. The above mentioned Five Trustees shall be the FOUNDER Trustees and form the Board of Trustees whose names are given in Chapter I and they be the Trustees for life.
3. The Board of trustees shall have a Chairman, General Secretary, Treasurer and such other office bearers as may be created by the Board of Trustees from time to time, for such period as deemed necessary.
4. The above mentioned office bearers shall be elected at the first meeting of Board of Trustees.

PART VIII **POWER OF THE BOARD OF TRUSTEES**

Without prejudice to the generality of powers vested in the Trustees, but, in accordance with the provisions of the Indian Trust Act 1882 and also subject to the Provisions of the Income Tax Act 1961, Income Tax Rules 1962, the board of Trustees shall have the following specific powers:-

1. To acquire by Purchase, gift, grant, exchange, lease, hire or otherwise properties all kinds including movable and immovable properties and to improve and add to the corpus of the Trust, finance and property subject to the terms and conditions as may be decided by the board of Trustees.
2. To invest the funds of the Trust in securities stipulated under the provisions of Section 13(1) (d) read with Section 13(5) of the Income Tax Act 1961.
3. To acquire or construct building or purchase properties and to rent out the same and to have income of the Trust.

PART IX

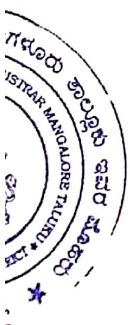
POWERS AND FUNCTIONS OF THE OFFICE BEARERS

1. CHAIRMAN:

- a) He shall preside over all the meetings of the Board of Trustees.
- b) He shall have General control over all the affairs of the Trust and the institutions under its control and its employees.

2. GENERAL SECRETARY:

- a) He/she shall generally be the Chief Executive of the Trust.
- b) He shall be in charge and responsible for the safe custody of all the records and documents relating to the Trust and its properties.
- c) He shall convene meetings of the Board of Trustees in consultation with the Chairman and maintain regular records of the proceedings of such meetings.
- d) He shall be the custodian of all correspondence and all financial statements and returns required in connection with the management of the trust.
- e) He shall implement all resolution of the Board of Trustees unless otherwise decided by the Trustees.
- f) He shall also carry out such other responsibilities and duties entrusted to him from time to time by the Board of Trustees.
- g) He or any other Trustee authorized by the Board of Trustees shall keep with him an amount not exceeding Rs. 2,000/- as impress, for urgent expenditure which may be drawn from the Bank and recouped as and when necessary.
- h) He shall maintain or cause to be maintained regular books of accounts of the Trust and authorize to keep with him Rs. 2,000/- (Rupees two thousand) cash only for day to day expenditure required for the Trust.

- i) All legacies, donations, subscriptions, shall be paid to the Treasurer whose receipt shall be valid and binding on the Trust.
 - j) He shall have the accounts of the Trust audited by a chartered accountant as decided and approved by the Board of Trustees.
 - k) The account of the Trust in Bank/s shall be operated in the manner decide by the Board of Trustees.
3. If any of the said office bearers of the trust resigns his post or any of such posts lies vacant for any other reason as narrated in part XI, the same shall be filled up by passing a resolution of the Board of Trustees at a meeting supported by three Trustees present.

PART X **CESSATION OF TRUSTEESHIP**

The trusteeship shall cease:-

1. By death of the Trustee or
2. By resignation, accepted by the board of Trustees.
3. By any trustee becoming bankrupt, lunatic is convicted of any criminal offence involving moral turpitude.
4. By expulsion as per Chapter XI.
5. By not attending 3 consecutive meetings of the Board of Trustees without the leave of the Board or without assigning any valid reasons in writing.
6. Cessation of Trusteeship for any reason shall not entitle any trustee or any person for the refund of any money paid by him or return of any donations or gifts etc. made to the Trust nor shall have any rights to avail of any facilities afforded by the Trust.
7. In the event of dissolution or winding up of the Trust, the assets remaining as one the date of dissolution shall under the Trustees but the same shall be transferred to another trust whose object are similar to those of this Trust and which enjoys recognition under section 80G of the Income Tax Act 1961.

PART XI **EXPULSION**

If any of the Trustee if found immoral or his conduct inside or outside the Trust is found detrimental to the interests or reputation of the Trusts, or if he/she behaves in a manner prejudicially affecting the trust and its institution and activities, he shall be liable of expulsion from the trust, by a resolution passed by at least 4 trustees present at a meeting of the board of Trustees. However before a Trustee is expelled he/she shall be given the proposed grounds of expulsion in writing and shall also be given an opportunity of being heard by the Board of Trustees.

1. PART XIV
NOTICE OF MEETINGS

There shall be give a notice of:-

2. 7 clear days' time for a meeting specified under Chapter XI and XVII.
3. In case of emergency however, meeting can be convened at shorter notice at the instance of the Chairman except meetings convened under Chapter XIII and Chapter XVII.
4. The accidental omission to give notice or the non-receipt of notice by any Trustees. Shall not invalidate the proceedings of any such meeting.
5. The mode of sending notices shall be determined by the Board of Trustees from time to time.

PART XV

PART XVII
AMENDMENTS TO THE DEED OF TRUST

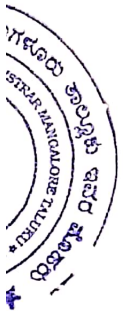
1. The Board of Trustees by its resolution, attended in person at a special meeting of the Board of Trustees reserve the power to amend, modify, delete or alter this deed of Trust, its aims and objectives so as to bring out the intention, if the same have this Deed of Trust and ensure that the provision of the Deed of Trust, in consonance with the Income Tax Act 1961, as amended from time to time.
2. No amendments to the Memorandum of Association and Rule and Regulations repugnant to the provisions of the Section 2(15), 11, 12 and 13 and 80G of the Income Tax Act, 1961 shall be made.
3. Further no amendments shall be carried out without the prior approval of the Commissioner of Income Tax.
4. But such change/s or alteration/s, amendment/s deletion/s etc., should not alter in any way the nature, or character of the Trust, and that neither the authors nor the Trustees shall have any power to revoke the objectives of this Trust at any time.
5. The proposed amendment/s, deletion/s, modification/s, alteration/s. or change/s in the Deed of Trust shall be communicated to the Trustees along with the notice of the meeting of the Board of Trustees, convened for the said purpose.

PART XVIII
FINANCIAL YEAR

The financial year of the Trust shall commence from 1st April and ends with march 31st of every English Calendar year or as per the Financial year fixed by the government from time to time.

PART XIX
GENERAL

1. The Trust created herein shall be irrevocable.
2. If the services of any person are found beneficial to the Trust, he may be co-opted as Honorary Trustee, for such period as the Trustees deem fit, or invited for any particular meeting of the Trust for his help, opinion or advice, but he shall not be entitled to vote.
3. All the Trustees shall be the life members and the executive committee shall for period of five years only. The executive committee is empowered to form an advisedly board of two members.
4. If any vacancy arises in the board of trustees, due to resignation, death, or for any other reasons enumerated in Chapter X the same

5. Any action of the Trustees shall not be questioned or invalidated on the ground that he powers and discretions have been exercised imprudently. The doctrine of Cypress shall apply in the execution of trust objectives. If the Board of Trustees find it expedient in the interest of managing trust properties.
6. All the deeds and other documents to be executed by or on behalf of the trust shall be done by the Chairman and the General Secretary of the Trust, jointly and the trust may sue or be sued jointly in the name of Chairman and General Secretary of the Trust.
7. The Trustees may reimburse themselves or any and discharge the liabilities incurred for the execution of the aims and objectives of the Trust in exercise of the powers vested in them, out of the finances and properties of the Trust.
8. It is further made clear, that if for any reason the objectives for which the Trust has been created cannot be achieved or fulfilled and consequently the trust cannot function and or the institutions started by the Trust cannot be run efficiently for any reason whatsoever, then, the Board of Trustees by a majority of four of its members present at a special meeting convened for this purpose, shall handover all the assets, immovable, movables, equipment's etc., along with all outstanding and liabilities to any institution/s with similar objectives of this Trust.
9. The Trustees are wholly indemnified against any expenses and losses, incurred or suffered or any payments made by them in administration of the Trust and such expenses, losses and payments shall be borne by the trust, and none of the Trustees shall in any manner be personally liable or responsible for the same.
10. The First officer bearers of the Trust shall hold office for a period of 5 years, and thereafter the office bearers shall be elected from among the Trustees for a period of 3 years.
11. All office bearers to hold office one, are eligible for re-election.
12. The office bearers elected for the term/s mentioned in Chapter XIX clause (10) after the expiry of their term shall continue in office till the election of fresh office bearers.

At meetings, ordinary or special only subject/s mentioned in the notice shall be discussed and decided.

For any urgent business connected with any affairs of the Trust, the office bearers may meet as and when required under the directions of the Chairman of the Trust, and take such decisions as may be necessary.

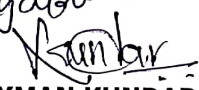
15. Powers not defined in this Deed of trust are vested with Board of Trustees, which shall exercise its discretion in deciding matters that come up before them, from time to time.
